In terms of section 14(1) of the NCTE Act, 1993, the above Society / Trust / Institution had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for starting M.Ed course of one year duration with an annual intake of 25 students at Ravathur Post, Near Sulur Boat Lake, Irugur(via), Coimbature District-641103, Tamilnadu.

- 2. On the basis of the scrutiny of the documents submitted by the institution, input received from the Visiting Team Report and videography, the SRC in its 128th meeting held during 7-8th March, 2007, has decided to grant conditional recognition to the above institution as per para 7(11) of Regulations of NCTE Notification dated.27.12.2005 published in the Gazette of India on 13.01.2006.
- 3. Now the institution shall undertake appointment of the faculty / staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. (A duly constituted selection means that a nominee of the affiliating body / University as applicable, subject expert of the affiliating body / University and a nominee of the State Government appointed by the affiliating University and the State Government respectively).
- 4. Terms and conditions of service of staff are to be maintained as per NCTE norms and standards.
- 5. Attention of the institutions concerned is also drawn to para 7(12) of NCTE Regulations, which reads as "The institution concerned, after appointing the requisite faculty/staff, shall put the information on its official website and also formally inform the Regional Committee concerned. The Regional Committee concerned shall then issue a formal unconditional recognition order". Hence the institutions shall host the details in the institution website and thereafter submit the details to SRC-NCTE.
- 6. Besides the above, the institution is required to submit the following:
